ORDER:

In the reference 1st read above, orders were issued according sanction for creation of **2151** posts of Teachers in various categories in the Tribal Welfare Ashram Schools under Tribal Welfare Department.

- 2. In the reference 3^{rd} read above, permission was accorded to the Commissioner of Tribal Welfare, Hyderabad to fillup **750** (Seven Hundred and Fifty only) posts of teachers in various categories, shown in the Annexure to the order for Ashram Schools under Tribal Welfare Department by way of Direct Recruitment by conducting Special DSC as per the service conditions laid down in the GO 2^{nd} read above based on the proposals of Commissioner of Tribal Welfare, Hyderabad.
- 3. In the reference 4th read above, The Commissioner of Tribal Welfare, Hyderabad has been requested to send a separate proposals with justifications etc., for filling up balance **1401** (One Thousand Four Hundred and One only) of SGBTs posts for taking further action in the matter.
- In the reference 5th read above the Commissioner Tribal Welfare has stated that Government has sanctioned the total 2151 teacher posts of various categories in Tribal Welfare Institutions, consequential vacancies of teachers in various categories. As per the service conditions laid down 70% of posts shall be filled in by promotion and 30% posts shall be filled in by direct recruitment in respect of certain promotion categories and in respect of certain initial categories 100% posts are earmarked for direct recruitment. Accordingly 750 posts are to be filled in by direct recruitment and the balance 1401 posts are to be filled in by promotion. Further she has stated that due to filling up of the posts earmarked by promotion from the respective feeder categories, the posts in the feeder category would become vacant and in certain cases the feeder category vacancies are to be filled in by direct recruitment with 100% and in certain cases it will be again 30% by direct recruitment and 70% by way of promotion and so on. Ultimately all the consequential vacancies are to be filled in by direct recruitment only so that the entire sanctioned posts would be filled and the details are as follows:

- 5. The Commissioner of Tribal Welfare, Hyderabad has further stated that otherwise all these 1401 posts which are earmarked for filling up by way of promotion would remain vacant in respective feeder categories consequent on filling up of these posts by promotion.
- 6. The Commissioner of Tribal Welfare, Hyderabad has further stated that unless all the sanctioned 2151 posts are filled in, the quality education in the Tribal Welfare Educational Institutions will adversely affect and thereby defeat the purpose and spirit of the Government in sanctioning the additional posts required to the Tribal Welfare Educational Institutions. The Commissioner of Tribal Welfare, Hyderabad has therefore requested to accord permission for filling up of these 1401 consequential vacancies through Direct Recruitment.
- 7. In the circumstances stated by the Commissioner of Tribal Welfare, Hyderabad in the reference 5th read above, the Government after careful examination of the matter hereby accord permission to the Commissioner of Tribal Welfare, Hyderabad for filling up of **1401** (One Thousand Four Hundred and One only) consequential vacancies posts of Teachers in various categories shown in the annexure to this order for Tribal Welfare Ashram Schools under Tribal Welfare Department by way of direct recruitment.
- 8. The Commissioner of Tribal Welfare, Hyderabad shall take further necessary action accordingly.
- 9. This order issues with the concurrence of Finance (SMPC.I) Department, vide their U.O.No.22882-B/ 271/ A4/ SMPC-I/2011, dt.22-09-2011.
