- 3. In the reference 3rd read above, the Government permitted to take admission into 9th class @ 30 students in each section for 4 sections vide letter Rc.No.3810/RS.2/2011-1, dated: 06.04.2011.
- 4. In the reference 4th read above, the Secretary, APSWREI Society requested the Government to examine and permit the following changes to the said G.O. and issue orders on the amendments. The details are given below:-

 - c) Para No.5: The ratio of students is 70:30 for Boys and Girls and the caste ratio is SCs-75%, CC SCs-12%, STs-6%, BCs-5% and OCs-2% read as "Admissions into 9th Class onwards Boys 2 Sections, Girls 2 Sections. And in SC category 70% is for students from SWR Institutions and SW hostels and 30% to SCs from any other recognized institution through an entrance test with the same caste ratio i.e., SCs-75%, CC SCs-12%, STs-6%, BCs-5% and OCs-2%" and
